

# **Declaring property and debts**



## Why is the law necessary?



- To decrease the grey economy
  - Conformity of income and expenses
- Amnesty
  - Pay PIT of 15% for the nondeclared taxable income for the period 1.1.1991 -31.12.2007







### What should be declared?



- Latvian tax residents must declare (1.3.2012-1.6.2012) according to the actual state as at 31.12.2011 at 24:00, in excess of LVL 10 000:
  - 1. Property, incl.:
  - Money (in cash or in an account) should be in a bank on 1.06.2012
  - Shares (also the beneficiary under money laundering laws)
  - Financial instruments (certain securities, money-market instruments); MLL
  - Savings in private pension funds; life insurance with accumulation
  - Issued loans and other assets in LAT and abroad (form LVL 1 abroad RE,

shares, vehicles, fin. instr.)

- 2. Taken loans, outstanding part
- Not apply to RE (Land Book), vehicles (reg.), officials

# How to determine the value?



- shares, RE, fin. instr. purchase (paid + invested)
- savings accumulated
- Loans outstanding (taken) & not collected (given)
- in a donation agreement (if none exists the cadastral, for others – nominal value or market price)
- indicated in the inheritance deed (if not, -»-)
- exchange agreement (if not returned purchase val.)
- formation costs
- for paintings, objects of value, and others owner's opinion!?
- if the purchase v. cannot be determined market v. or nominal value or any other identifiable or verifiable value.
- Bank of Latvia rate as at 31.12.2011.
